Entry-level classifications within the City are eligible for Veterans' Preference. To be considered for Veterans' Preference, the following documents must be completed and attached to your employment application (or submitted directly to the City of Modesto Human Resources office) by the final filing date:

- Veterans' Supplemental Application (page 2)**
- Copy of your discharge papers (DD-214)**

The City of Modesto Human Resources Department will add five (5) percentage points to the eligible list score of qualified candidates who are Veterans, as defined in the California Government Code¹.

¹ California Government Code 18973: "Veteran" means any person who has served full-time for 30 days or more in the armed forces in time of war or in time of peace in a campaign or expedition for service in which a medal has been authorized by the government of the United States, or during the period September 16, 1940, to January 31, 1955, or who has served at least 181 consecutive days since January 31, 1955, and who has been discharged or released under conditions other than dishonorable, but does not include any person who served only in auxiliary or reserve components of the armed forces whose service therein did not exempt him or her from the operation of the Selective Training and Service Act of 1940."
