

## Blight Abatement Advisory Committee February 24, 2022, 11:00AM-12:00PM, via Zoom

## **MINUTES**

- I. Call to Order: Chairperson Lynn Dickerson called the meeting to order at 11:05 AM.
- II. Roll Call

- V. Consent Items
