



## Turf Replacement Rebate Program: Expanded Eligibility

Offer available July 1, 2025 thru June 30, 2026 and subject to fund availability

City of Modesto water customers may be eligible for a \$1 per square foot rebate for the already converted yard/pre-existing grass area with any qualifying artificial turf products or drought tolerant land within the last 120 days. The rebate amount may not exceed \$1,500 per residential City of Modesto water account and/or \$3,000 per commercial City of Modesto water account. Funding is limited and applications will be accepted on a first-come, first-served basis. The City reserves the right to terminate this program at any time and for any reason.

Outdoor landscaping is the single largest use of water in a typical California home or business. In most yards, grass consumes the most water, therefore reducing or eliminating how much grass you have can significantly reduce your water use.

3. A City of Modesto representative may contact you to schedule a brief appointment to verify your existing landscape.

### Program Guidelines

#### Who Qualifies?

- City of Modesto customers who pay a water utility bill to the City of Modesto.
- Customer accounts that are in good standing.
- Tenants who provide written approval from the property owner or property manager.
- Area converted must have had grass or traditional sprinklers intact previously, verifiable with picture submitted in order to qualify for the rebate.

#### Timelines

- Program applies to turf replaced within the last **120 days**.
- An inspection may be scheduled once the application has been received.
- Itemized dated sales receipts for the products used in the conversion are required and must be dated within the last **120 days of application submitted**.

## Turf Replacement

- Turf replacement must be drought tolerant and permeable (allow water to penetrate into the ground).
- When replacing turf, irrigation system must be capped, eliminated or converted to drip.
- Turf replacement must be maintained and kept in healthy condition for a minimum of 5 years.
- Turf replacement must be installed within the Modesto City service area and at the address listed on the application.
- Applicants must provide a list of proposed plants with the application.
- If only part of the lawn is converted, the new planting area must be on a separate valve.

## Rebates

- Existing artificial turf, turf installation costs, new construction, accessories, and taxes do not qualify. Reimbursement is for products used in the conversion. Labor cost does not qualify.
- Rebate checks will be mailed within 8 weeks after completing the rebate process.
- Rebate amount cannot exceed the cost of the products used in the conversion. Dated, itemized sales receipts are required at the post-inspection.
- Rebates are limited to \$1,500 per residential utility billing account per fiscal year (July 1, 2025 – June 30, 2026).
- Rebates are limited to \$3,000 per commercial utility billing account per fiscal year (July 1, 2025 – June 30, 2026).

## Application and Rebate Approval or Denial

- On-site compliance verification is required.
- Original itemized, dated sales receipt for the products used in the conversion area is required at the inspection.
- Incomplete, incorrect or unsigned applications cannot be processed. We will contact you with any discrepancies and may require you to submit a new application.
- Customer must fulfill all program guidelines to be eligible for rebates.

## Other Considerations

- The Rebate Program is not responsible for materials lost by mail.
- Submission or possession of a rebate application does not guarantee receiving a rebate.
- Rebates are processed on a first-come, first-served basis.
- Funding for this rebate program is limited to available resources.
- Rebate amounts are subject to change without notification.
- This program shall at all times be subject to change or termination without prior notice.

- The rebate value cannot exceed the actual cost of the products used in the conversion.
- An original itemized dated sales receipt is required at the inspection.
- Limit of \$1,500 rebate per residential account per fiscal year (July 1, 2025-June 30, 2026)
- Limit of \$3,000 rebate per commercial account per fiscal year (July 1, 2025-June 30, 2026)
- Compliance with attached guideline is required.

## Agreement of Terms and Conditions

The City of Modesto may deny any application that does not meet program requirements. The undersigned expressly agrees that the City may inspect all items submitted for the Turf Replacement Rebate Program. The City does not guarantee the performance of any turf replacement; does not warrant any turf replacement or installation to be free of defects, the quality of the workmanship, or the suitability of the premises or the turf replacement installation. The undersigned further agrees to hold harmless the City of Modesto against all loss, damage, expense and liability resulting from the loss, destruction or damage to property arising out of or in any way connected with the turf replacement. The City reserves the right to alter this program at any time. Funding for this rebate program is limited to available resources.
