I, _____, (hereafter the “Undersigned”) am an adult over the age of eighteen (18) and the parent/legal guardian of _____, the Minor Volunteer Applicant identified above (hereafter the “Volunteer Minor Applicant”), and I permit the Volunteer Minor Applicant to participate in volunteer activities (the “Activity”) of the City of Modesto’s Parks, Recreation & Neighborhoods Department (the “City”). The Undersigned is fully aware of the risks and hazards connected with the Activity and hereby elects to voluntarily allow the Volunteer Minor Applicant to participate in said Activity, knowing that the Activity may be hazardous to me and my property. THE UNDERSIGNED VOLUNTARILY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH, which may be sustained as a result of being engaged in such Activity.

1. In exchange for participating in the Activity, the Undersigned on behalf the Volunteer Minor Applicant and of his or her self, heirs, estate, insurers, representatives and assigns hereby fully releases, waives, discharges and covenants not to sue the City of Modesto, its employees, elected and appointed officials, volunteers, attorneys, agents and any other person(s) acting on the City’s behalf (hereafter the ‘Releasees’) from any and all claims for bodily injury (including death), and other liability, damages, lawsuits, expenses (including but not limited to, medical expenses and attorneys’ fees) to the Volunteer Minor Applicant or any other person, arising out of or relating to the Volunteer Minor Applicant’s participation in the Activity and agrees to waive any rights to make the above claims through a lawsuit or otherwise against the Releasees above.

2. The Undersigned understands and acknowledges responsibility for any injury or damage the Volunteer Minor Applicant causes to others during the Activity and hereby agrees to indemnify, defend, and hold harmless the Releasees from any and all claims for bodily injury (including death), and other liability, damages, lawsuits, expenses (including but not limited to, medical expenses and attorneys’ fees) resulting from participation in the Activity, whether caused by any act or omission of ordinary negligence of Releasees, or otherwise.

3. By signing this waiver to volunteer with the City of Modesto Parks, Recreation & Neighborhoods Department you (the volunteer) understands that you are expected to comply with all measures outlined by the State of California Governor’s Office as outlined at www.COVID.CA.GOV, as well as any restrictions put in place by the Stanislaus County Health Services Agency as they pertain to safety and preparedness for COVID-19. All volunteers are encouraged to stay home should they have a fever or other COVID-19 symptoms. Volunteers must comply with all state and local social distancing requirements, including the wearing of a mask, in effect at the time of the activity. Higher risk individuals over the age of 65 or individuals with underlying medical conditions should not participate in or attend this program. By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by participating in this program, and I hold the City harmless from any and all COVID-19 related liability or responsibility due to my or my child’s participation in this program.

4. The Undersigned hereby grant to the City of Modesto and their legal representatives and assigns, the irrevocable and unrestricted right to use and publish photographs of me or my child or guardian under 18 years of age, for advertising and any other promotional purposes and in any manner and medium; to alter the same without restriction; and to copyright the same. I hereby release the City of Modesto and their legal

representatives and assigns from all claims and liability relating to said photographs.

5. The Undersigned expressly agrees that the foregoing release and waiver and indemnity agreement are intended to be as broad and inclusive as permitted by California law.

6. The Undersigned understands that I may have rights under Civil Code Section 1542, which reads as follows: "A general release does not extend to claims that the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release and that, if known by him or her, would have materially affected his or her settlement with the debtor or released party." The undersigned expressly waive any rights under California Civil Code Section 1542.

By signing below, I, _____, acknowledge and represent that I HAVE READ THIS AGREEMENT CAREFULLY; I FULLY UNDERSTAND IT AND I VOLUNTARILY AGREE TO ITS TERMS. No oral representations, statements or inducement, apart from this written agreement have been made. If any portion of this agreement is declared invalid by a court, the remainder shall continue in full force and effect.
